# India Launches Fourth SSBN S4, Boosting Indigenous Naval Power Stare

22-Oct-24

India has successfully launched its fourth nuclear-powered ballistic missile submarine, codenamed S4 (Star), enhancing its strategic deterrent capabilities amidst rising geopolitical tensions. This new submarine, which features 75% indigenous content and is equipped with K-4 missiles with a 3,500 km range, signifies a critical advancement in India's naval prowess, following the commissioning of INS Arighat and the upcoming INS Aridhaman. The launch underscores India's commitment to a credible second-strike capability, particularly against adversaries like China, where conventional platforms face increased vulnerability. With the government's focus on enhancing underwater capabilities through SSBNs and additional nuclear attack submarines, India is strategically positioned to dominate the Indo-Pacific region and ensure national security in a complex geopolitical landscape.

# India's FRCV Tank Wows Serbian Experts with Advanced Design and Tech Share

India's Future Ready Combat Vehicle (FRCV) program has received commendations from Serbian military experts for its innovative design and advanced technology aimed at replacing the T-72 tanks in the Indian Army. The FRCV features two versions—a manned turret and an unmanned turret—both incorporating a dual autoloader system, enhancing ammunition capacity and safety. Notable attributes include impressive gun elevation angles suited for mountainous terrains, a domestically developed 1,500 horsepower engine, and Al-powered targeting systems, positioning the FRCV as a formidable asset in India's defense strategy. This initiative reflects India's commitment to modernizing its armed forces amid evolving security challenges.

#### IIT Madras Innovates High-Speed Ramjet FSAPDS Shells for MBTs Share

IIT Madras, led by Major General Rajiv Narayanan, is developing ramjet-powered Fin Stabilized Armour Piercing Discarding Sabot (FSAPDS) shells to enhance the lethality and range of main battle tanks (MBTs) against modern armored threats. This innovative ammunition aims to extend effective range to 6-9 kilometers, overcoming traditional FSAPDS limitations and countering advanced Active Protection Systems (APS). The use of ramjet technology will allow for higher speeds, making interception by enemy defenses more challenging. This project is set to significantly transform armored warfare dynamics, ensuring Indian armored forces maintain a technological edge on the battlefield while improving crew safety and strike capability.

# Indian Army Revamps T-90 Bhishma Tanks, Boosts Self-Reliance Share

The Indian Army has successfully overhauled the T-90 Bhishma tanks domestically for the first time, enhancing self-reliance amid disruptions in spare parts supply from Russia due to the ongoing conflict in Ukraine. This significant achievement, conducted at the 505 Army Base Workshop, extends the tanks' operational life by up to 20 years, ensuring combat readiness. The overhaul includes upgrades to mechanical, electronic, and fire control systems, aligning with India's Aatmanirbhar Bharat initiative that aims to bolster indigenous defense capabilities. This advancement not only strengthens military preparedness but also reduces dependence on foreign suppliers, showcasing India's commitment to enhancing its defense infrastructure.

# India's 3rd SSBN, likely INS Aridhaman, to launch in 2025 SHARE

India is set to commission its third nuclear-powered ballistic missile submarine (SSBN), likely named INS Aridhaman, in 2025, marking a significant enhancement to its nuclear triad. This

Arihant-class submarine will be larger, boasting an increased displacement that allows for a greater number of Submarine Launched Ballistic Missiles (SLBMs) and extended underwater endurance. Key upgrades include enhanced stealth features, advanced sonar-absorbent coatings, and a more efficient nuclear reactor, bolstering India's second-strike capability and deterrence strategy. The addition of INS Aridhaman signifies a substantial leap in India's maritime defense, reflecting the country's commitment to maintaining robust strategic capabilities in an evolving security landscape.

# Indian Navy's UHM Helicopters Set for First Flight in 2025 SHARE

The Indian Navy is set to conduct the first test flight of its Utility Helicopters-Maritime (UHM) variant of the Advanced Light Helicopter (ALH) Dhruv in May 2025, marking a significant enhancement in its aviation capabilities. Hindustan Aeronautics Limited (HAL) is currently testing and certifying systems for the UHM, which will feature foldable rotor blades, a modified tail structure, and an advanced sensor suite. The UHM is designed for missions such as anti-submarine warfare and search and rescue operations, optimizing space on naval vessels while ensuring operational efficiency. This strategic development underscores India's commitment to advancing its indigenous defense capabilities in maritime operations.

# ADA Seeks Bids for Canopy Bubbles for AMCA Fighter Jet Share

The Aeronautical Development Agency (ADA) has issued a tender for six canopy bubbles for India's Advanced Medium Combat Aircraft (AMCA), adhering to military specifications. This initiative is crucial for advancing India's indigenous 5th-generation fighter jet, emphasizing the importance of high durability and optical clarity in the canopy's design. The selected supplier will not only manufacture the components but also enhance the design and validate the manufacturing process. The canopy must meet stringent criteria, such as pressure tolerance and bird strike resistance, ensuring its reliability in modern aerial combat conditions, thereby reinforcing India's commitment to bolstering its defense capabilities through indigenous development.

# Raghu Vamsi Machine Tools Launches Advanced Micro Turbojet Engine S SHARE

Hyderabad-based Raghu Vamsi Machine Tools Pvt Ltd is developing a new micro turbojet engine, the Indra RV40, which aims to generate a thrust of 400N while weighing only 4.2 kilograms. This follows their successful Indra RV25 engine with 240N thrust and highlights their collaboration with IIT Hyderabad for technical expertise. The Indra RV40's enhanced power-to-weight ratio positions it to significantly advance the UAV industry, facilitating the development of larger, more capable drones that can carry heavier payloads and operate in challenging environments. This initiative underscores India's growing capabilities in indigenous defense technology and its

commitment to enhancing aerial surveillance and operational effectiveness.

# Should India Join South Korea's KF-21 Engine Development? Share

22-Oct-24

South Korea is nearing a decision on its indigenous engine program for the KF-21 Boramae fighter jet, potentially opening avenues for collaboration with India on engine development, particularly for India's Advanced Medium Combat Aircraft (AMCA). This partnership could accelerate timelines, reduce costs, and enhance technological capabilities for both nations' defense industries. However, challenges include the complexities of jet engine development, compatibility of defense ecosystems, and the necessity of involving established players for critical components. Collaborating could provide India with access to advanced technologies and help South Korea reduce reliance on Western firms, fostering greater self-reliance in defense capabilities for both countries.

### Delivery of INS Chakra III Delayed to 2028 Amid Sanctions Share

The delivery of INS Chakra III, a Russian Akula-class nuclear-powered attack submarine to the Indian Navy, has been delayed until 2028 due to complications from the Russia-Ukraine conflict and Western sanctions affecting critical components. Originally expected in 2025, this lease is vital for enhancing India's underwater capabilities and maintaining credible deterrence in the Indo-Pacific region, particularly following the return of INS Chakra II in 2021. The submarine will undergo significant upgrades to integrate Indian communication and sensor systems, ensuring compatibility with India's naval operations. Despite the delays, the acquisition reflects India's commitment to bolstering its naval strength amid growing security challenges.

# India's Defense Exports Shouldn't Be Limited by Political Agendas Share

The Supreme Court of India dismissed a PIL aimed at halting arms exports to Israel, highlighting the need for India to balance its moral stance with its ambitions as a defense exporter. Defense expert Ranesh Rajan emphasized that India should adopt a pragmatic approach, focusing on competitiveness rather than the ethical implications of arms sales to controversial buyers. He argued that limiting exports based on political concerns could stifle innovation and undermine India's goal of self-reliance in defense production. #### Reliance Infra to invest ₹10,000 crore in Maharashtra defense hub S SHARE

Reliance Infrastructure Ltd plans to invest Rs 10,000 crore over the next decade to establish India's largest integrated defense manufacturing project, the Dhirubhai Ambani Defence City (DADC), in Ratnagiri, Maharashtra. Covering 1,000 acres, the project aims to produce a wide range of explosives, ammunition, and small arms, and may involve joint ventures with up to six global defense firms. This initiative positions Reliance alongside major players like Tata, Adani, and Larsen & Toubro, bolstering India's self-reliance in defense manufacturing. With existing defense licenses and prior export success, this investment reflects India's commitment to enhancing its domestic defense capabilities and economic growth through private sector participation.

### Indian Army Integrates Indigenous Tech in Combat Exercise S SHARE

The Indian Army recently concluded the Swavlamban Shakti exercise at Babina Field Firing Ranges, showcasing the integration of indigenous technologies in future combat strategies. Involving 1,800 personnel and 210 armored vehicles, the exercise highlighted the collaboration with over 40 industry partners and emphasized the importance of self-reliance in defense, aligning with the Aatmanirbhar Bharat initiative. This event underscores India's commitment to enhancing its combat capabilities through indigenous innovation, ultimately aiming to strengthen national security and reduce dependency on foreign military imports. #### **Geopolitics and Security Alliances**

#### China and India Reach Agreement to End Ladakh Border Standoff Standoff

China has confirmed an agreement with India to end the over four-year military standoff in eastern Ladakh, with both sides reaching a resolution on patrolling along the Line of Actual Control (LAC). Indian officials, including External Affairs Minister S. Jaishankar, reiterated that soldiers will return to previous patrolling practices, marking a significant diplomatic breakthrough. This agreement follows extensive negotiations between the two nations, aimed at resolving issues stemming from the intense border clash in June 2020. Overall, the diplomatic engagement demonstrates India's commitment to maintaining stability along its borders while ensuring national security through strategic dialogue.

# Zelenskyy: US backing key to sway Germany on NATO bid S SHARE

Ukrainian President Zelenskyy is optimistic that post-US election, allies will bolster Ukraine's NATO membership aspirations, despite Germany's hesitations that may shift with stronger US backing. He clarified that Ukraine is not seeking nuclear weapons for defense against Russia, but rather desires NATO membership, referencing the 1994 agreement where Ukraine relinquished its nuclear arsenal for security guarantees that were subsequently ignored. In response, Russian President Putin

warned of consequences to Zelensky's statements, underscoring the ongoing tension between Ukraine and Russia. This situation highlights the critical need for international support to strengthen Ukraine's security architecture, particularly as it navigates its complex relationship with NATO and seeks to deter Russian aggression effectively.

### EAM Jaishankar: India-China Patrolling Pact Restores 2020 Status Share

22-Oct-24

India's External Affairs Minister S. Jaishankar announced an agreement with China on patrolling arrangements along the Line of Actual Control (LAC), allowing a return to pre-2020 conditions and signaling the completion of disengagement efforts. This development, described as a result of patient diplomacy, aims to restore peace and stability in border areas after tensions escalated due to Chinese military actions in 2020. While the agreement is a significant breakthrough, experts caution that rebuilding trust remains complex, with both nations still maintaining substantial troop presence. The upcoming BRICS summit, which will see discussions between Prime Minister Modi and President Xi Jinping, could further clarify the implementation of this agreement, particularly in sensitive areas like Depsang and Demchok.

Furthermore, India has implemented stricter regulations for investments from Chinese firms to prevent potential takeovers, highlighted by accusations against companies like Vivo and Xiaomi for financial misconduct. This cautious approach reflects India's commitment to safeguarding national security while balancing economic collaboration with China amidst rising tensions.

# Mahbubani: India Should Replace UK on UNSC for Strengthening It Share

Kishore Mahbubani, a former UNSC President, advocated for India to replace the UK on the UN Security Council, arguing that India's growing economic power warrants a permanent seat to strengthen the UNSC. #### Ufa Submarine Docks in Kochi, Boosting India-Russia Naval Ties Share

The Russian Navy's advanced Kilo-class submarine Ufa, along with the rescue tug Alatau, docked in Kochi on October 21st, reinforcing India-Russia maritime cooperation. The Ufa, known for its enhanced combat capabilities and stealth, underscores the significance of advanced joint research and production efforts in defense technology. #### Army Chief: Trust Restoration Post India-China Border Talks S SHARE

With an estimated capacity of 10-12 GW, this dam aims to bolster flood management, water flow correction, and power generation, at a projected cost of around

Rs 1 trillion. However, local opposition persists due to environmental concerns, complicating NHPC's data collection efforts. While the project promises economic benefits and strengthens national security against Chinese influence, it raises vital questions around ecological impacts and community welfare, highlighting the need for a balanced approach to development in strategically significant regions.

#### **Military Operations**

# Security Forces Seize AK-56 and Weapons in Manipur Operations Share

The exercise also fosters professional ties through cultural and sports interactions, emphasizing a holistic approach to military cooperation.

# Security forces conduct search along LoC after Pakistani drone sighting in

Security forces in Poonch district, Jammu and Kashmir, launched a search operation along the Line of Control after firing at a suspected Pakistani drone that hovered momentarily over Indian territory before retreating. #### Punjab Worker Killed in Kashmir Terror Attack During Call S SHARE

Gurmeet Singh, a 45-year-old construction worker from Punjab, was killed in a terrorist attack in Ganderbal, Jammu and Kashmir, while speaking to his wife on the phone. The attack, attributed to unidentified terrorists, targeted a group of laborers working on a tunnel project, resulting in seven fatalities, including Singh and a local doctor. Singh's family described him as the primary breadwinner, emphasizing the urgent need for government support for his grieving family. This incident underscores the ongoing security challenges in Kashmir and the vulnerability of non-local workers, highlighting the critical need for enhanced protective measures for civilians in conflict areas.

# Five Naxalites Killed in C-60 Commandos' Anti-Insurgency Operation S SHARE

Five Naxalites were killed in a gunfight with the C-60 commandos of the Gadchiroli police in Maharashtra's Bhamragadh taluka, ahead of the state assembly elections on November 20. # PAFF Claims Tunnel Attack in Kashmir Linked to Chinese Interests S SHARE
